

## SUBMISSION REQUIREMENTS

CROWN MEDIA UNITED STATES, LLC (“Company”) and THE BLACK LIST, LLC (“Black List”) are collaborating to host this Program (the “Program”), which is specifically designed to identify one or more writers interested in and capable of telling authentic stories about the Black experience.

The Program, is subject to the following requirements:

- You must post an original screenplay, pilot teleplay (one-hour or one half-hour), stage play, or musical (no webseries, please) (“**Materials**”), telling an authentic story about the Black experience, on [www.blcklst.com](http://www.blcklst.com) and opt-in to the Program during the Submission Period. Ideally, the selected writer will focus their storytelling on self-purpose, self-empowerment, love, sisterhood, faith, and community, and will have an interest in romance films and television.
- **You must agree to (1) these Submission Requirements, (2) all terms relating to the Program posted on Black List’s website, which you should review and read in full, and (3) the Submission Agreement, which governs the submission of your Materials to Company and Black List. The Submission Agreement includes important, legally binding terms and conditions, including arbitration of any disputes, which you must read in full before accepting.**
- If requested, you must submit by a date determined by Company the following additional materials, which are also governed by the Submission Agreement:
  - A professional, true, accurate, and complete resume and biography;
  - Contact and other personal information; and
  - Executed originals of the Submission Agreement.
- If selected by Company, you must agree to enter into a WGA-minimum blind script deal to write an original television movie for Company (or a WGA-signatory entity affiliated with Company). You represent and warrant that you are a member of the WGA in good standing.
- You must be at least 18 years of age and not a minor in the state or country of your residence at time of submission.
- You must not have earned more than \$500,000 in the aggregate in connection with all prior script and/or teleplay work over the past 10-years.
- If the submitted Materials are written by a team consisting of you and one or more other writers, (i) each member of that writing team must comply with these Submission Requirements, including agreeing to and executing the Submission Agreement described below and (ii) all members of the writing team must opt-out of the Program if any other member becomes ineligible (including as a result of failing to timely agree to the Submission Agreement or failing to timely provide the additional materials listed above).
- The submitted Materials must be wholly original to you and you must be the sole owner of all rights other than as expressly set forth above with respect to other writing team members. The submitted Materials must not in any way infringe upon the copyright of any person or entity or, to the best of your knowledge in the exercise of reasonable prudence, constitute libel, defamation or invasion of privacy or any other rights of any third party. You understand and agree that Black List will share any information that you provide in connection with the Program with Company.

**COMPANY RESERVES THE RIGHT TO CHOOSE NO CANDIDATE FOR INCLUSION IN THE PROGRAM IF, IN THE OPINION OF COMPANY IN ITS SOLE AND ABSOLUTE DISCRETION, NO ENTRY IS OF SUFFICIENT MERIT. MOREOVER, YOU ACKNOWLEDGE AND**

**UNDERSTAND THAT COMPANY RESERVES THE RIGHT TO SELECT FOR THE PROGRAM ONLY ONE MEMBER OF A WRITING TEAM (I.E., POTENTIALLY A TEAM MEMBER OTHER THAN YOU IF YOU ARE A MEMBER OF A WRITING TEAM), WITH SUCH SELECTION TO BE MADE IN COMPANY'S SOLE DISCRETION.**
